

**NOTICE OF THE PASSING OF A BY-LAW TO AMEND  
ZONING BY-LAW NO. 5000, AS AMENDED  
(TU-2010-002 – Beatty)**

**TAKE NOTICE** that the Council of The Corporation of the Township of Springwater passed **By-law No. 5000-123** on the **6<sup>th</sup> day of April, 2010**, under Sections 34 and 39 of the Planning Act, R.S.O. 1990, c.P.13, as amended.

**PURPOSE AND EFFECT**

**THE PURPOSE** of the proposed zoning by-law amendment is to permit a temporary use on lands located in Part Lot 45, Concession 2, former Township of Flos, now in the Township of Springwater, being Part 1 on 51R-3775, known municipally as 1398 Old Second Rd. North, Roll No. 4341 030 001 05200 0000.

**THE EFFECT** of the by-law is to allow the temporary placement of a garden suite on the lands, subject to an agreement with the Township.

**AND TAKE NOTICE** that any person or agency may appeal to the Ontario Municipal Board in respect of the by-law by filing with the Planning Department of The Corporation of the Township of Springwater not later than **3rd day of May, 2010** a completed Appellant Form (A1), available from the Planning Department or the Ontario Municipal Board's website, accompanied by the fee prescribed under the Ontario Municipal Board Act, R.S.O. 1990, s.100, Chap. O.28. The fee for an appeal to the Ontario Municipal Board is \$125.00. The cheque is payable to the "Minister of Finance" and must be certified.

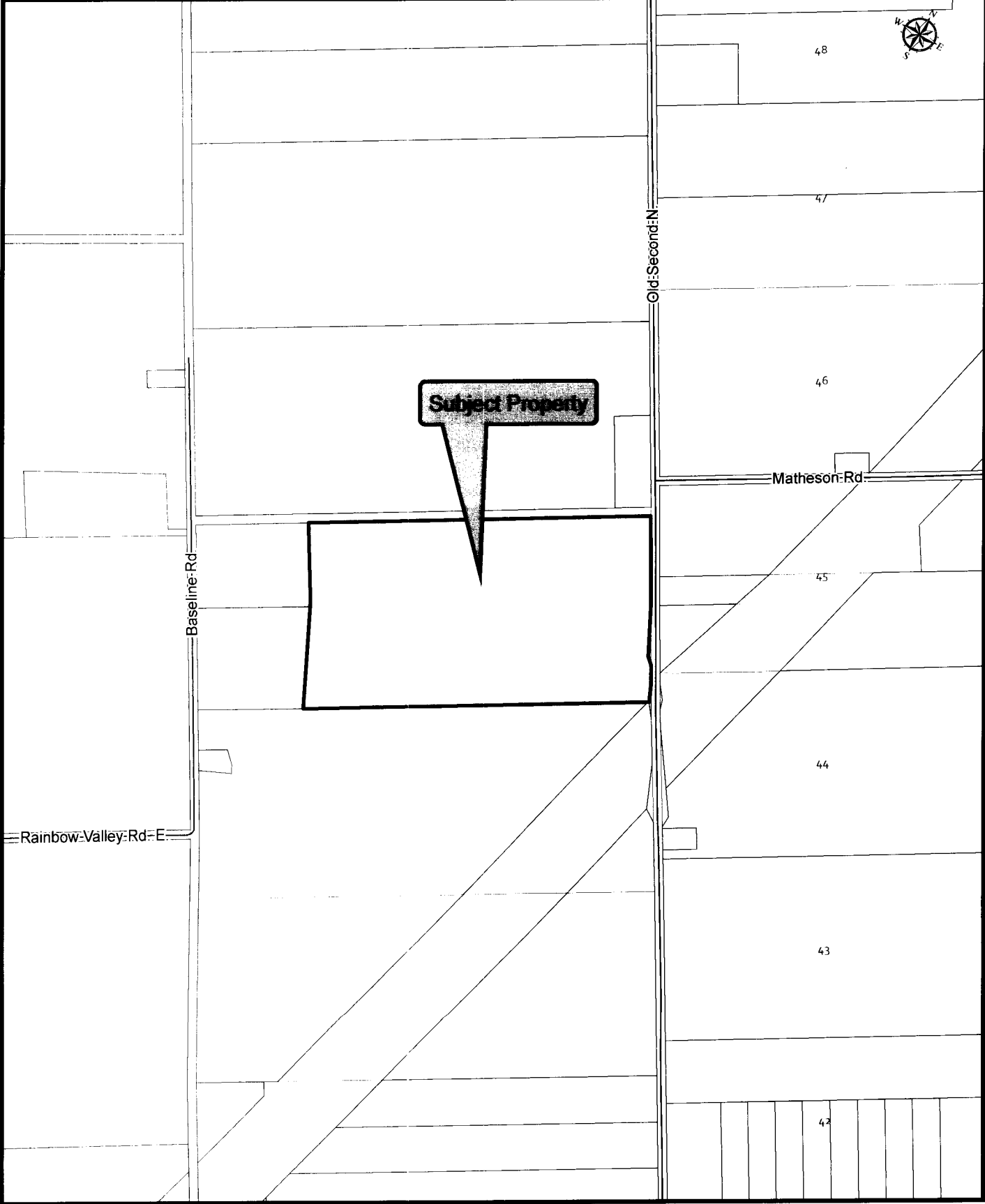
Only individuals, corporations and public bodies may appeal a zoning by-law to the Ontario Municipal Board. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf. If a person or public body who files an appeal of a decision of The Corporation of the Township of Springwater in respect of a proposed zoning by-law does not make oral submissions at a public meeting or written submissions to The Corporation of the Township of Springwater before the proposed zoning by-law is adopted, the Ontario Municipal Board may dismiss all or part of the appeal.

The Complete By-law is available for inspection at the Township of Springwater Administration Centre, 2231 Nursery Road during regular office hours, Monday to Friday, 8:30 a.m. to 4:30 p.m.
