
Notice of Public Hearing for Minor Variance

Take notice that an application to the Committee of Adjustment has been submitted for a minor variance to the Township of Springwater Comprehensive Zoning By-law 5000 pursuant to Section 45 of the Planning Act, c.P.13, R.S.O. 1990 as amended for lands known municipally as **7 Albert Street East** and legally described as Part of Lot 4, Part of Lot 5 on Plan 203, former Township of Medonte, now in the Township of Springwater, being Roll No. 4341 020 081 14300.

The purpose and effect of the application is to permit the construction of a 53.5 square metre (576.0 square foot) single storey detached accessory building (garage) with a 13.4 square metre (144.0 square foot) covered area within the interior side yard, which will exceed the maximum total area provisions and location provisions of By-law 5000, as described below:

1. A maximum total area of accessory buildings or structures of 75.0 square metres (807.3 square feet); whereas section 4.3.12 permits a maximum total area of accessory buildings or structures of 65.0 square meters (699.65 square feet); and,
2. The construction of single storey detached accessory building (garage) within the interior side yard, whereas Section 4.3.12 permits detached accessory buildings to be erected and used in the rear yard.

A location map is enclosed.

Please ensure all written submissions include your name, address and the application number.

If you wish to be notified of the decision of the Committee of Adjustment in respect of the proposed application, you must make a written request to the Township of Springwater

Committee of Adjustment by email, regular post or the drop box located at the Administration Building.

If you do not participate in the hearing or request notification of the Committee’s decision, it may proceed in your absence and, except as otherwise provided in the Planning Act and you will not be entitled to any further notice of the proceedings. Failure of the applicant(s) or their authorized agent to participate at any hearing may result in the automatic dismissal of the application.

A specified person or public body as identified in the Planning Act, R.S.O. 1990, c.P.13, as amended may appeal to the Ontario Land Tribunal with respect to any decision made by the Committee of Adjustment by filling with the Planning Department of the Corporation of the Township of Springwater with a complete notice of appeal setting out the reasons for the appeal and accompanied by the fee required by the Tribunal.
