## Notice of Public Hearing For Consent

**Take Notice** that an application to the Committee of Adjustment has been submitted for a Provisional Consent to Sever pursuant to Section 53 of the *Planning Act*, c.P.13, R.S.O. 1990 as amended for lands known municipally as **1446 Flos Road 4 East** being legally described as Lot 2 and Part of Lot 1, Concession 4, former Township of Flos, now in the Township of Springwater, Roll No. 4341 030 001 10900.

**The purpose** of the consent application is for approval of a surplus farm dwelling severance to sever a single detached dwelling from the farmland, for the purposes of farm consolidation. The application proposes to sever a parcel of land consisting of approximately 1.3 hectares (3.3 acres) with frontage on Flos Road 4 East.

The retained parcel is proposed to have a remaining lot area of approximately 97.9 hectares (242.0 acres) and frontage on Flos Road 4 East.

A location map and severance sketch are enclosed.

The Committee of Adjustment for the Township of Springwater will hold a hybrid meeting (in person at the Township Administration Centre and virtually via Zoom) to consider this application on **Wednesday, March 26, 2025 at 6:00 p.m.** The hearing will also be livestreamed on the Township's YouTube channel at: <https://www.springwater.ca/live>.

Interested stakeholders/residents that would like to comment/participate in the hybrid Council meeting **in person** are asked to please pre-register with the Township prior to Tuesday, March 25, 2025 at 5:30 PM.

Any person may make a submission in support of, in opposition to, or ask a question regarding the proposed Consent. Written submissions are recommended and can be made to the Planning Department by email, regular post or the drop box located at the Administration Building. Please ensure all written submissions include your name, address and the application number.

If you wish to be notified of the decision of the Committee of Adjustment in respect of the proposed application, you must make a written request to the Township of Springwater Committee of Adjustment by email, regular post or the drop box located at the Administration Building.

If you do not participate in the hearing or request notification of the Committee's decision, it may proceed in your absence and, except as otherwise provided in the Planning Act and you will not be entitled to any further notice of the proceedings. Failure of the applicant(s) or their authorized agent to participate at any hearing may result in the automatic dismissal of the application.

Notice of Public Hearing – B01/25

A specified person or public body as identified in the Planning Act, R.S.O. 1990, c.P.13, as amended may appeal to the Ontario Land Tribunal with respect to any decision made by the Committee of Adjustment by filling with the Planning Department of the Corporation of the Township of Springwater with a complete notice of appeal setting out the reasons for the appeal and accompanied by the fee required by the Tribunal.

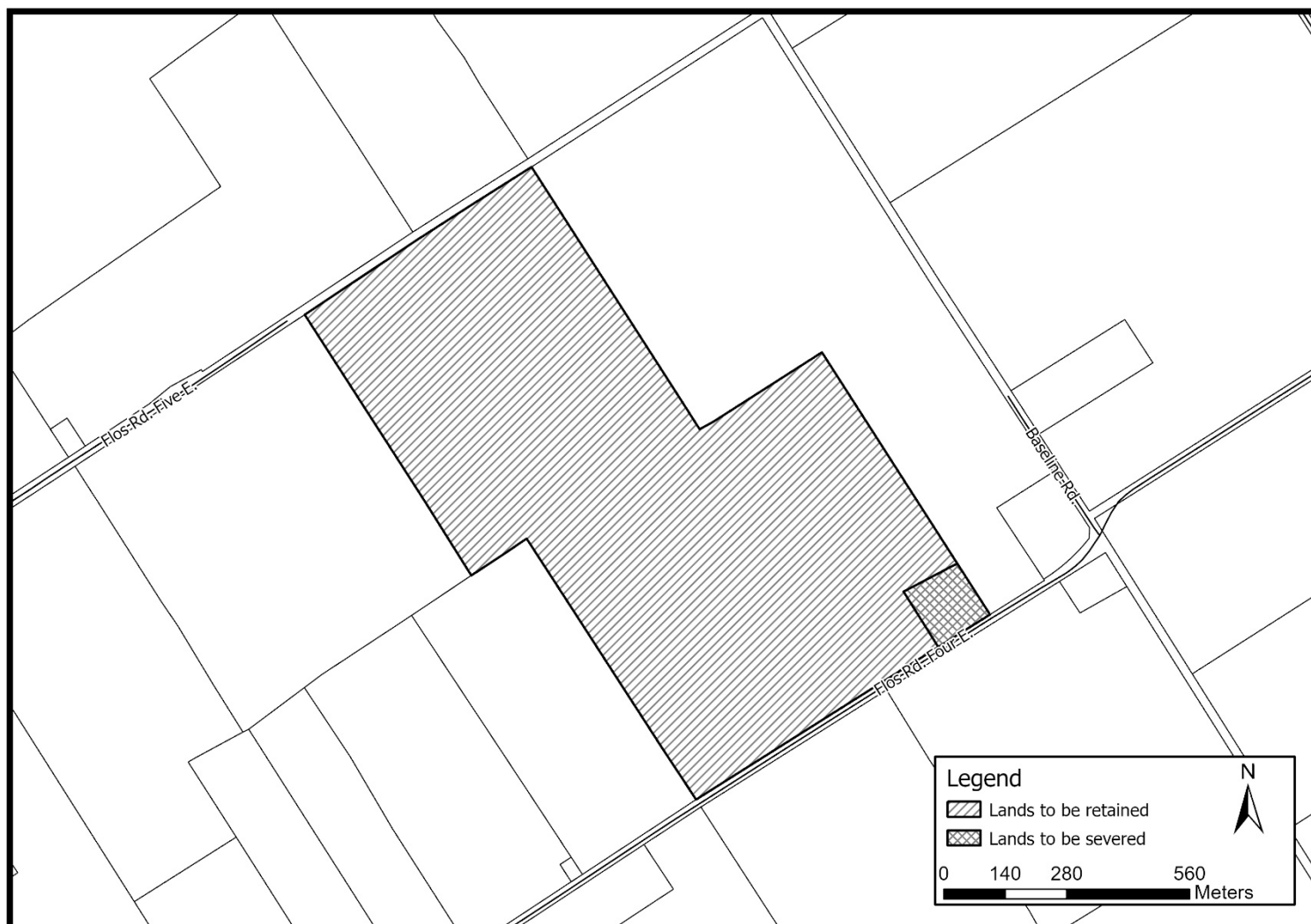
