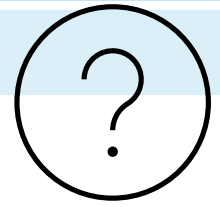

General Information:



Do I need a permit?

Yes, A building permit is required for a fireplace, woodstove or a solid fuel furnace. This information is provided for homeowners and contractors planning to install a solid fuel (wood, pellet etc.) burning appliance and/or chimney in a Single Dwelling Unit only. Please note that any installation of a non-masonry, solid fuel burning appliance (e.g., wood stove) shall comply with CAN/CSA-B365 and either CSA B415.1 or US EPA emission rates as it read on March 16, 2015. Masonry fireplaces are not addressed in this guide. For further information on such projects please contact Building Services or review Section 9.22 of the Building Code.

Does my installer need to be W.E.T.T Certified?

Yes, please ensure that the installer is W.E.T.T certified as we will ask for a copy of the W.E.T.T report following installation of your wood burning appliance.

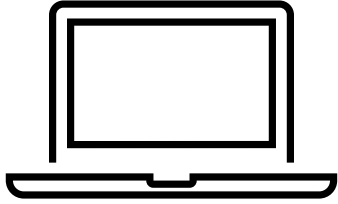

Outdoor Solid fuel appliances

The Township of Springwater [Outdoor Furnaces By-law](#) further regulates the location of outdoor furnaces. Please review the by-law to ensure an outdoor furnace is permitted at your property prior to planning your installation.

- Minimum lot area of 2 Ha (4.9 Acres)
- Minimum 50 m to other existing dwelling, 30 m to any residential zoned land, and 20 m to any lot line.

All permit applications are to be submitted online via our [Web Portal](#). Before you begin, please ensure that all required documents are complete and signed (as applicable). Scan each document separately and give it a recognizable file name and save it to your computer. For further assistance please see our [Digital Permit Submission Guide](#).

Permit Issuance:



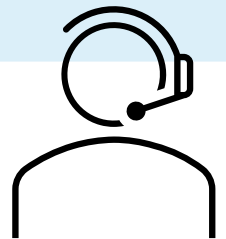
Once the permit has been completely reviewed by all internal and external agencies the applicant will be contacted via email and informed of any action required for the permit to be issued. **Permit fees are payable upon issuance.**

Building permit fees are determined by an established cost per square foot, and/or by established flat fees as detailed in the Township of Springwater

Scheduling Inspections:

After the permit has been issued it is the responsibility of the applicant to schedule inspections throughout the completion of the work. The required inspection(s) will be outlined on the permit card provided at the time of issuance.

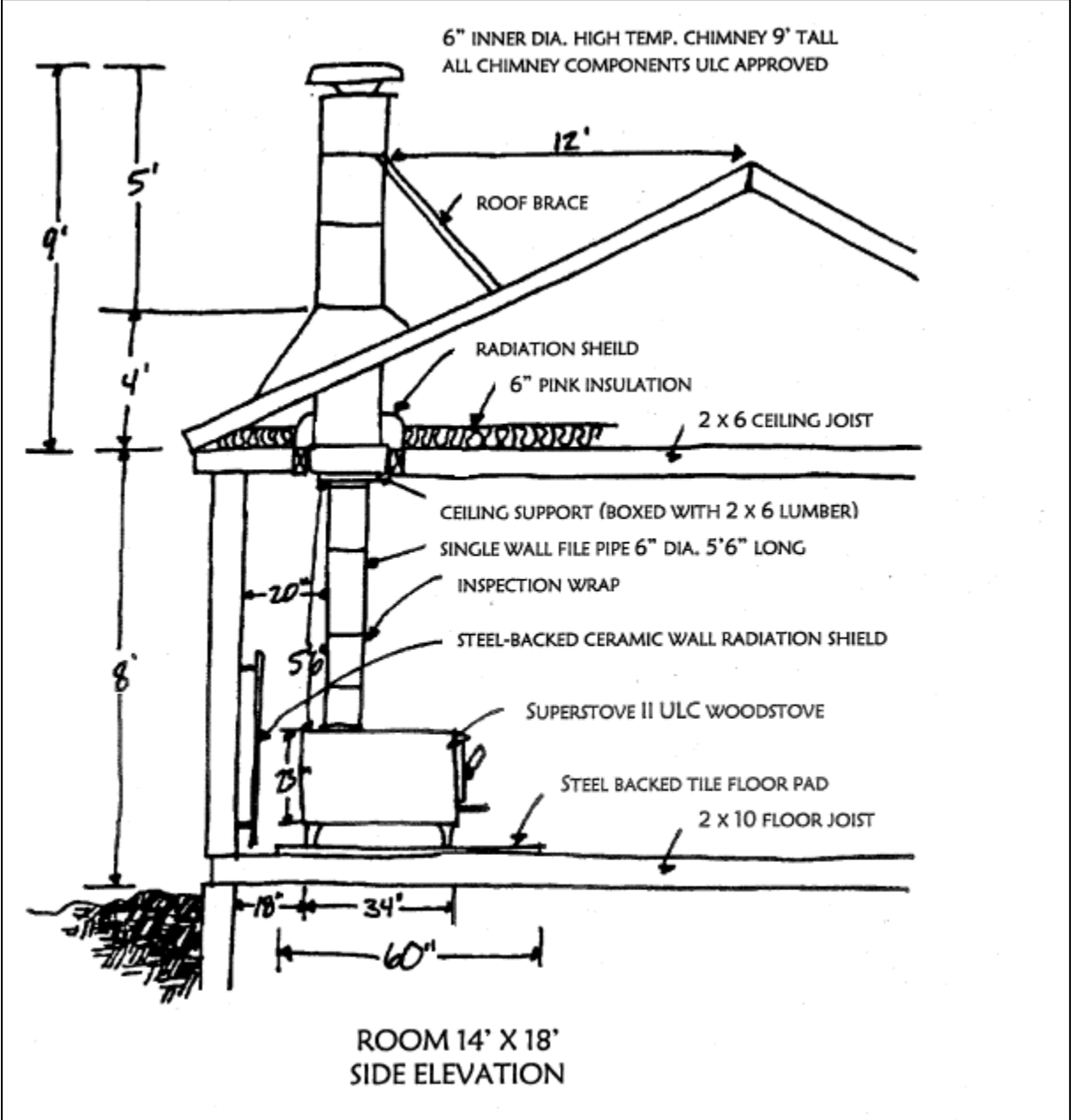
- Application for a Permit to Construct or Demolish & Schedule 1: Designer information



2. Required Supporting Documents:

- Front view and side view drawing showing:
Wall shielding, flue pipe and chimney arrangements looking at it from the front and the side.
- Top of plan drawing showing:
Appliance position in the room, wall clearances and shielding and floor pad
– from a “birds’ eye view”
- Manufacturer’s Installation Instructions (for the solid fuel burning appliance)

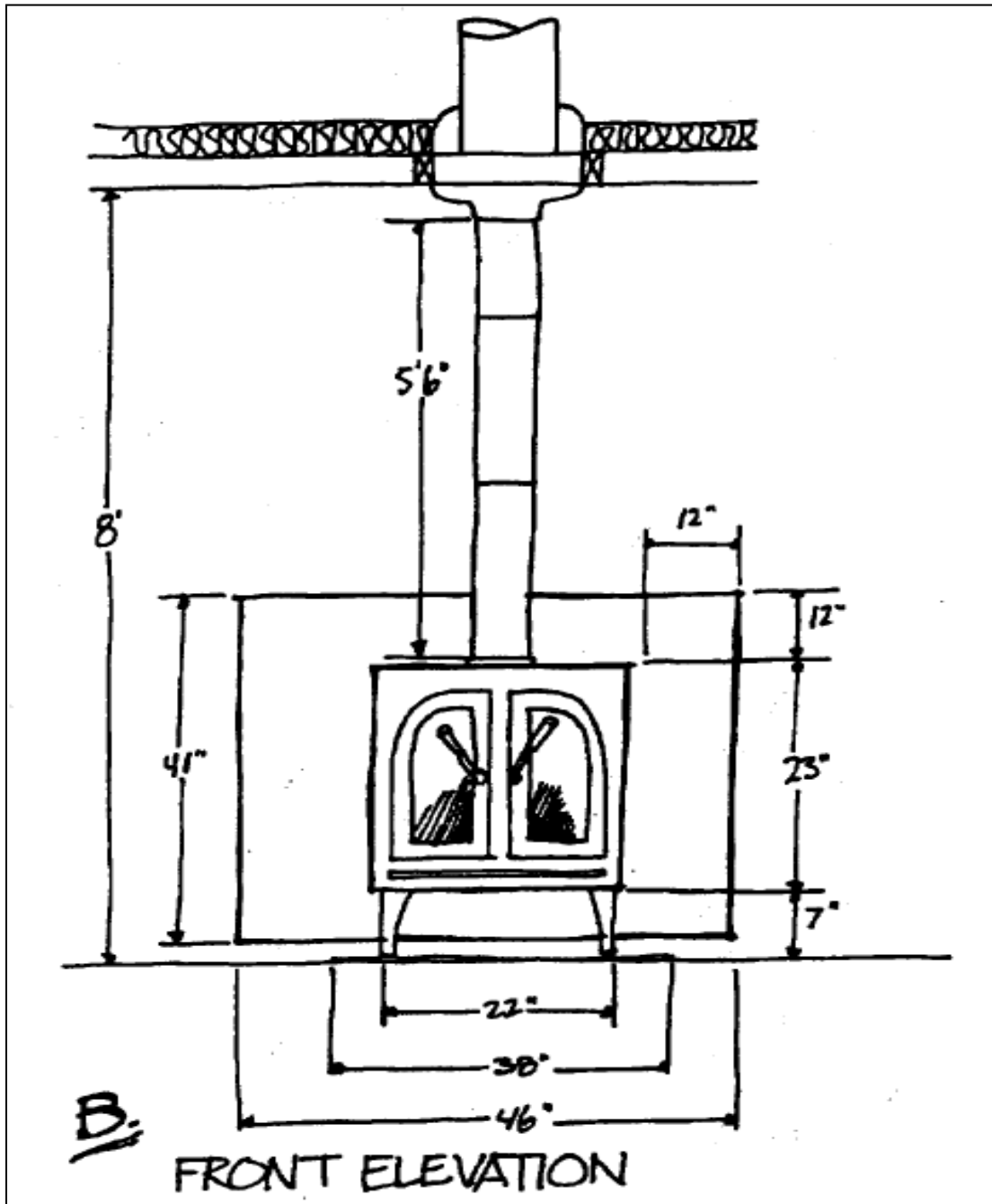


21 Springwater Trail – Side elevation

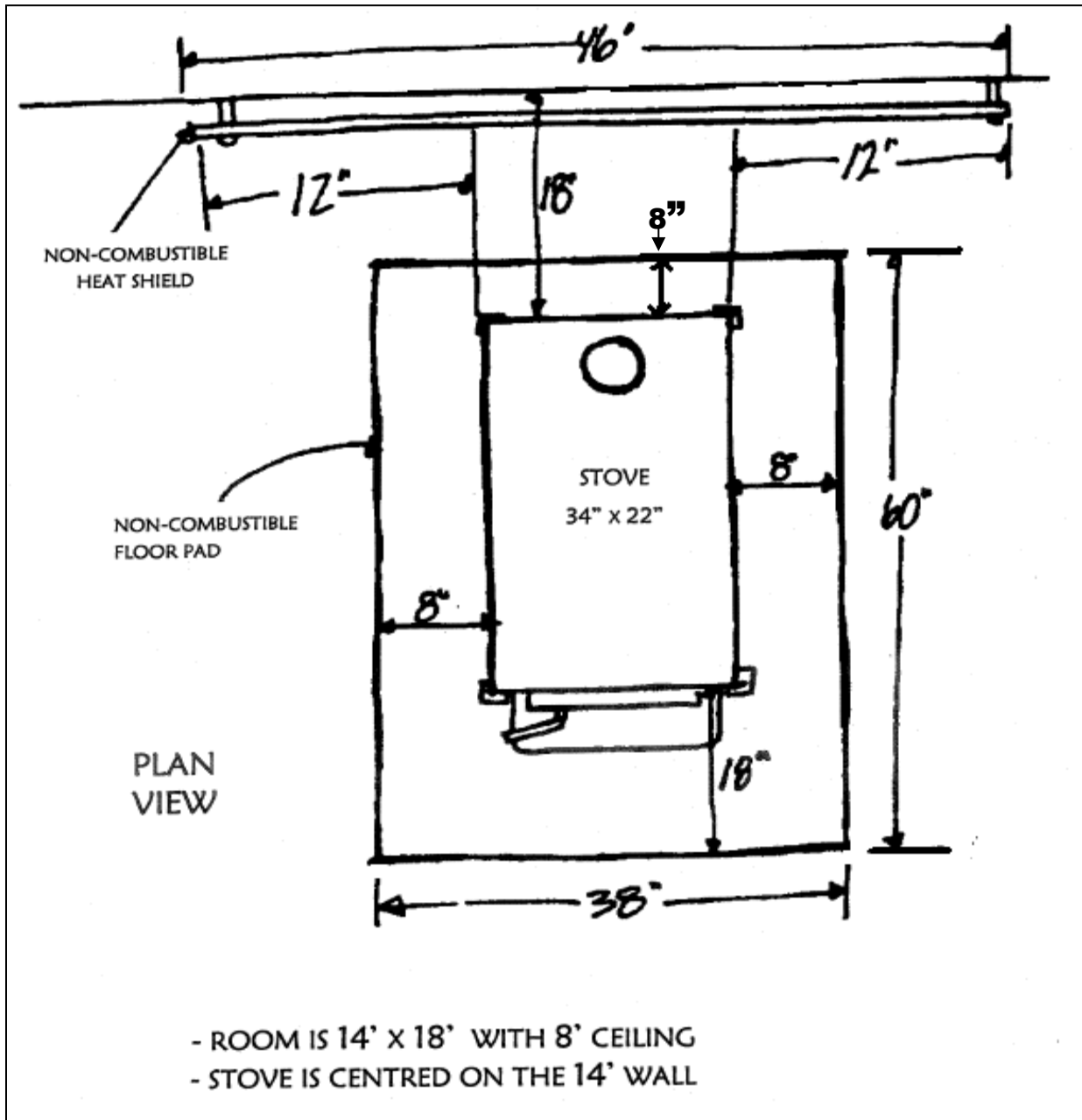


21 Springwater Trail – Front elevation

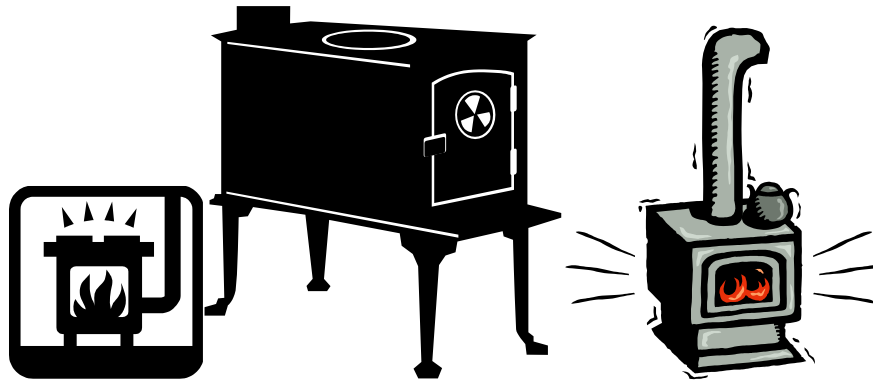
21 Springwater Trail – Top elevation
