
Notice of Public Hearing for Minor Variance

Application No.: A06/26
Applicant: Barrie Sports Hub Inc.

Take notice that an application to the Committee of Adjustment has been submitted for a minor variance to the Township of Springwater Comprehensive Zoning By-law 5000 pursuant to Section 45 of the Planning Act, c.P.13, R.S.O. 1990 as amended for lands known municipally as **7 Currie Drive** and legally described as Pt E1/2 Lt 14 Con 5 Vespra as in RO1008426 & Pt 2, 51R25991, Except ROW in RO1008426; former Township of Vespra, now in the Township of Springwater, being Roll No. 4341 010 003 28500.

The purpose and effect of the application is to permit the construction of a Soccer Dome and surface parking facilities in relation to the Private Club use that will be deficient/in excess of the following provisions of Zoning By-law 5000, as described below:

- A minimum number of required parking spaces of 60 spaces for a Private Club use, whereas Section 3.41.3. requires a minimum number of parking spaces of 1 space for each 7 persons maximum design capacity;
- A minimum front yard width of 6.0 metres to a surface parking area, whereas Section 3.41.5. does not explicitly permit parking areas within required yards and setbacks;
- A minimum interior side yard width of 2.5 metres to a surface parking area, provided that no parking space is closer than 7.5 metres from an interior side yard lot line, whereas Section 3.41.5 does not explicitly permit parking areas within required yards and setbacks; and
- A maximum height for a Soccer Dome of 22.5 metres (73.82 feet) taken from the highest point whereas Section 30.3.9. states that no building or structure in the Institutional zone shall exceed a maximum height of 11.0 metres (36.09 feet).

A location map and concept plan are enclosed.

Any person may make a submission in support of, in opposition to, or ask a question regarding the proposed variance application. Written submissions are recommended and can be made to the Planning Department by email, regular post or the drop box located at the Administration Building. Please ensure all written submissions include your name, address and the application number.

If you wish to be notified of the decision of the Committee of Adjustment in respect of the proposed application, you must make a written request to the Township of Springwater Committee of Adjustment by email, regular post or the drop box located at the Administration Building.

If you do not participate in the hearing or request notification of the Committee's decision, it may proceed in your absence and, except as otherwise provided in the Planning Act and you will not be entitled to any further notice of the proceedings. Failure of the applicant(s) or their authorized agent to participate at any hearing may result in the automatic dismissal of the application.

A specified person or public body as identified in the Planning Act, R.S.O. 1990, c.P.13, as amended may appeal to the Ontario Land Tribunal with respect to any decision made by the Committee of Adjustment by filing with the Planning Department of the Corporation of the Township of Springwater with a complete notice of appeal setting out the reasons for the appeal and accompanied by the fee required by the Tribunal.
